## About the Position:

We are seeking motivated and experienced Hydrovac Operators to join our team. As a Hydrovac Operator, your responsibilities include driving to assigned job sites to excavate, trench, remove rocks, dirt, or other materials to locate underground utilities in a safe manner. While your exact responsibilities can vary from day to day you will be responsible for successfully operating the equipment using the on-board vacuum and high-pressure water to safely expose underground utilities, pipelines, and infrastructure.

- Must have a current DOT medical certificate

- Must be self-motivated, able to work with minimal supervision
