### **About the Position**

We are seeking motivated and experienced Private Utility Locators/SUE Field Technicians. The Private Utility Locator/SUE Field Technician will be working under the direction of the Utility Division Manager and will perform utility locating for surface, subsurface, and aerial utilities and structures. After the initial training is completed, Private Utility Locators/SUE Technicians are responsible for the correct, safe, and efficient locating of underground utilities including, but not limited to, telecommunications, electric, power, cable TV, gas, water, and sewer systems. This includes taking time to thoroughly search for underground utilities in an area, properly marking the location, and completing all necessary paperwork following company guidelines.

### **Requirements**

- Criminal Background and Motor Vehicle History checks required
- Valid Driver's License required
- Subject to Pre-Employment and Random Drug Screens
- High School Diploma or equivalent is required
- Able to work in all outdoor elements for extended periods of time
- Must be self-motivated, able to work with minimal supervision
- Must have good communication skills (verbal and written), attention to detail and accuracy, and the ability to read and understand maps, records, and prints.

- Follow the standard operating procedures for targeting, locating, mapping, field sketching, test hole documentation, etc.
- Properly target and locate utilities, above and below ground.
- Ability to accurately complete all paperwork and deliverables for each job.
- Correct use, technique, and maintenance of the locating equipment.
- Out-of-town travel may be required.
- Follow all safety practices and procedures
- Willingness to learn/experience skills in technical utility locating, surveying best practices, GPR utility locating, site map/plan reading, and Maintenance of Traffic (MOT)
- Working knowledge of Excel, Word, PDF editor.
